MOBILE CLINICS: OVERCOMING ACCESS BARRIERS TO SEXUAL AND REPRODUCTIVE HEALTHCARE (SRH)





FPA Sri Lanka's 'Crisis Response Project' (Supported by UNFPA and DFAT) addresses the SRH needs of many underserved women in rural, hard-to-reach areas in this time of recession and economic crisis. Multiple Mobile Clinics were organised by the Nuwara Eliya, Batticaloa, Ampara, Koggala, Seethawaka, Wathupitiwala and Colombo Service Delivery Points.

In Nuwara Eliya, the clinic is operated via a functional bus that provides a full range of services and has the ability to reach the estate community directly.

Maternity kits containing hygiene and sanitary items and other items tailored to the needs of mothers were also distributed at all locations. This initiative aimed to provide necessary items that can significantly impact a woman's comfort and physical and psychological health.









Under this project, many community awareness programmes are also being carried out.

Knowledge about sexual and reproductive health services and access to adequate care have the power to improve the lives of people.

HEALTHCARE WORKER TRAININGS - CRISIS RESPONSE PROJECT



Three-day trainings took place for selected healthcare community workers from the six districts our SDPs are located in to enhance their capacity on SRH and MHPSS (Mental Health and Psychosocial support services).

The UNFPA-funded and DFAT-supported project aims to provide life-saving reproductive health and protection services to the most vulnerable women and girls, with a particular emphasis on preventing maternal morbidity and all forms of gender-based violence. The services will be provided through FPA Sri Lanka's 7 SDPs in Nuwara Eliya, Batticaloa, Ampara, Koggala, Seethawaka, Wathupitiwala, and Colombo, covering six districts in the country and targeting all women and girls of reproductive age in the selected districts.

Some of the main topics addressed were SRH, Maternal Health, STDs & HIV, Mental Health and Psychosocial Support, Gender and Sexual orientation, types of GBV, Screening, Case detection and referral, support services and counselling, Psychosocial Services, Roles and responsibilities of a health worker in the community (Ethics in SRH service provision and Counselling – Confidentiality, Privacy, Gender-sensitive counselling, communications) and recording and reporting processes. 100 healthcare workers will be trained over four months under this project.

Ten counsellors (7 from SDPs and three hired counsellors) have commenced implementing the One-call – call centre hotline application that enables women and girls to receive counselling and psychological support from 8 am – 8 pm daily.

RESPONDING WITH ESSENTIAL SRHR PROVISION AND NEW DELIVERY (RESPOND PROJECT)



The project aims to restore services impacted by COVID-19, particularly to marginalized populations such as young people, people living in poverty, people with disabilities, garment and estate factory workers, LGBTQI and key populations, and urban and slum dwellers. CREATING YOUTH FRIENDLY SPACES FOR SRH LITERACY IS A MUST!



Comprehensive Sexuality Education protects children and helps build a safer, inclusive society!

CSE not only provides children and young people with ageappropriate and phased education on human rights, gender equality, relationships, reproduction, sexual behaviours risks and prevention of ill health but also emphasizes values such as respect, consent, inclusion, non-discrimination, equality, empathy and responsibility

Our Wathupitiwala Service Delivery Point conducted a three-day interactive workshop for students of President's College Veyangoda.

EMPOWERING SRI LANKAN NURSING STUDENTS IN DELIVERING RESPONSIVE HEALTH CARE

The SRH essentials course for H & D Nursing school students in Arayampathy, Batticaloa, aimed to provide interactive learning opportunities with scenario-based case studies, presentations, group work and a time for discussion and questions.

At the end of the workshop, participants were able to:

- Develop the skills and confidence to talk with patients about their sexual and reproductive healthcare needs
- Have a thorough knowledge of contraceptive methods
- Have an understanding and knowledge of antenatal and postnatal care
- Gain knowledge and skills in the prevention, control and treatment of sexually transmitted infections (including HIV /AIDS



INTRODUCING YOUTH TO HUMANITARIAN ACTION!



Advocating for and responding to the sexual and reproductive needs of people in humanitarian settings is a key priority of FPA. We also believe young people can play a vital role in humanitarian action!

To strengthen young people's capacities to be effective humanitarian actors and support government organizations and local in humanitarian response, youth volunteers from the districts of Nuwara Eliya and Koggala were trained to prepare them as leaders and responders in an emergency situation. FPA Sri Lanka coordinates with the Disaster Management Centre when responding to a crisis in the country.

SIMEX 2022

Although it is impossible to completely eliminate disaster risk, countries that design policy and legislative frameworks and that prepare their institutions in line with the goal, targets and priorities for action have a greater capacity to manage disaster risk and, therefore to reduce the impact of disasters when they occur.





SimEx 2022 is the first roll-out of the Simulation Exercise in the Asia region and was conducted by the Humanitarian Hub of IPPF SARO. Several national-level stakeholders, including the Ministry of Health, Ministry of Women, Child affairs and Women empowerment, Disaster Management Centre, National Disaster Management Centre, National Child Protection Authority, SL Army and Women and Children's Bureau of the SL Police, as well as representatives from several CSOs were present at the training.

With the orientation of all key organizations involved in disaster response, every one providing the same standard of service can be ensured to all populations in need.

FPA's SPRINT IV Project provides lifesaving sexual and reproductive health support in emergencies incorporating the Minimal Initial Service Package (MISP). It is an internationally accepted minimum standard of care for reproductive health, pioneered and rolled out by IPPF. <u>Click here</u> to view some testimonials.



A two-day residential training programme was conducted on the 8th and 9th of December at Mandarina Hotel, Colombo. The training programme covered various topics relating to Sexual and Gender-Based Violence and raising awareness of referral mechanisms. SKPA PROJECT UPDATES





SKPA Kickoff in Colombo

Whilst Sustainability of HIV Services for Key Populations in Asia Program-2 (SKPA-2) officially started on 1 July 2022, a kick-off workshop was held in Bangkok in mid-August which really helped set the wheels in motion. The workshop brought together SKPA-2 subrecipients, The Australian Federation of AIDS Organizations(AFAO) Team, SKPA-2team as well as key stakeholders such as representatives from the Global Fund, UNAIDS, and WHO amongst others.

Colombo had its own Kickoff meeting on the 23rd of September with the Executive Director, Thushara Agus, AFAO representatives joining virtually and the SKPA Sri Lanka team in attendance. The event brought together other key stakeholders, including representatives from the Ministry of Health, The National STD/AIDS Control Programme, Key Population Focal Points, Country Coordinating Mechanism CCM representatives and the Human Right Commission. The goal of the event was to launch SKPA2's year one priorities, with the baseline report being vital among the list of year one priorities.

Completion of Baseline Assessment

FPA Sri Lanka is one of several partners working to deliver the Sustainability of HIV Services for Key Populations in South-East Asia (SKPA-2). Designed to improve the sustainability of evidence-informed, prioritized HIV services for key populations in Bhutan, Mongolia, the Philippines, and Sri Lanka, the SKPA programme is directed by four objectives: Accelerate financial sustainability of HIV service for key populations; Improve strategic information availability and use; Promote sustainability of programs which support key populations; Remove human rights and gender-related barriers to services.

These important and ambitious objectives need to be realized with a country-specific strategy and, as a way of understanding the current situation for each objective, with the need to fine-tune strategy and track progress through the life of the project, SKPA conducted a baseline assessment. The assessment comprised of two parts: a literature review, in which key documents relevant to HIV and key populations were analyzed, and a series of interviews with individuals from important stakeholder organisations. These include stakeholders from civil society organisations and community groups, national and subnational governments, the Country Coordinating Mechanism, and development partners. The team was led by Jim Rock in the four countries, and Dr. Kumari Navaratna, Ambika Satkunanathan, and Sathish Kumar worked in Sri Lanka to conduct the assessment together with the International Consultants. The final report is expected at the end of this year.

The Principal Director of AFAO, Felicity Young and Cookie Mansuda were also in Sri Lanka at this time to meet with stakeholders and discuss progress of the programme.

Community Voices in the National HIV/STI Strategic Plan (NSP)

The National STI/HIV Strategic Plan is presently being drafted by the National HIV/AIDS Control Programme for the years 2023-2030. The costed action plan would direct Sri Lanka's response in the period leading up to the year 2030, and SKPA responded to the need for the inclusion of community recommendations as a way of enriching the interventions and direction of the NSP.

Following a two-day intensive consultation with Key Population organizations and individual activists, a set of recommendations titled Community Voices for the NSP were provided to Dr. Rasanjali Hettiarachchi, Director of the National STD/AIDS Control Programme and the coordinator of the NSP drafting process, Dr. Janaka Weragoda.



Community-Led Monitoring Kicks Off

Community Led Monitoring is an important aspect of community engagement in HIV programme delivery to ensure quality and responsive HIV services for the key vulnerable populations impacted by the HIV epidemic. It involves activities that are carried out by community-led key population organizations and community members to assess the quality, availability, accessibility and acceptability of the HIV services they receive.

SKPA established a Technical Working (TWG) Group to oversee this process. The TWG comprising technical experts from both government and community-based key population- led organizations, is chaired by Mr. Palitha Vijayabandara of Lanka Plus.

Transgender specific healthcare clinic to be launched

Discussions have commenced with Trans Organizations and Healthcare Facilities about the roll-out of a Transgender specific Healthcare Facility.

Activities commenced in SKPA 1 will provide the basis for partnering with Community Based Organizations providing services for the Transgender community as SKPA initiates a healthcare clinic that caters to the very specific needs of the Transgender community. The initial plans include working with the National HIV/AIDS Control Programme as well as with other related government authorities and private service providers.

Country Visit by the AFAO team

SKPA SL team hosted Mike Merrigan-Technical Director, SKPA2 and Matthew Kusen, Senior Technical Officer, SKPA 2, in Sri Lanka for a five-day country visit. The visiting delegation met with stakeholders from the National STD/AIDS Control Programme, Key-population representatives and other Government officials.

The interviews and meetings were beneficial for the SKPA team as we embark on a reprogramming following the Baseline Assessment.





Pregnancies under the age of 20 years are defined as teenage pregnancies. This is a global problem in high, middle and low-income countries in poor communities which lack education and employment opportunities.

As reported by WHO, in January 2020, approximately 12 million teenage mothers between the ages of 15 -19 mothers gave birth, and 7.7 million girls gave birth before their fifteenth birthday from the developing region.

Sri Lanka is a developing country facing the same problem that burdens the health sector and economy. As reported by the Family Health Bureau, 4.1 per cent of registered pregnancies were adolescent pregnancies in 2020. It shows a slight reduction in the prevalence when comparing the rate over the last decade.

It is noted that the pregnant adolescent is at higher risk of having an unsafe abortion and related complications such as sepsis, long-term fertility issues and maternal death as the extreme. It is estimated that 3.9 million abortions are considered unsafe out of 5.6 million abortions that girls undergo between the ages of 15 and 19.

Problems associated with teenage pregnancy are psychological stress and nutritional demand of the adolescent mother, complications related to the pregnancy such as eclampsia, puerperal endometritis and systemic infection and fetal & neonatal complications. Teenage pregnancy and complications are among the leading causes of death in this age group globally.

Feto-neonatal problems associated with teenage pregnancy are congenital anomalies, fetal growth restriction, and increased perinatal morbidity and mortality. Stillbirth and neonatal death are 50 % higher in fetuses/infants of this group than in the 20-29-year age group.

Teenage pregnancy is a preventable problem in the community/world by educating and empowering the community. Sri Lanka, a culturally bound country in South Asia, had an incidence of 4 % adolescent pregnancy in 2020.

Proper age-appropriate reproductive health education regarding the reproductive health of adolescence will improve their knowledge and prevent them from misinformation from inaccurate sources. Knowledge and access to birth control methods will prevent adolescent pregnancy. Though the termination of pregnancy is not legalized in the Sri Lankan context, it may reduce septic abortion and its complication.

A National Strategic Plan adopted by the Family Health Bureau in cooperation with the Ministry of Health in Sri Lanka may reduce adolescent pregnancy and pregnancy-related complications by providing adolescent and youth-friendly health services.

Adolescents are the nation's and the world's future, and they need to be safeguarded from harm and illtreatment. Proper implementation of the sustainable development goal in the Sri Lankan context is mandatory to improve adolescent health.

In conversation with Ganga Shyamalee Assistant Director - Finance



You joined FPA in 2004. Explain, in brief, your career journey.

After my graduation, before me joining FPA in 2004, I worked in two other organisations. One of which was Mast Lanka Group, now known as Brandix Lanka. I joined FPA as a Management Trainee and was promoted to Manager- Accounts after three years. After being in that position for six years, I was promoted to Senior Manager- Accounts. In 2017, I was promoted to Assistant Director - Finance. This is my 18th year of service!

You have seen many changes in the work systems and procedures, from manual to digitalisation. How has this transformation been? Has it all been positive?

Yes, it has all been positive.

When I joined FPA, the staff salary cheques were written by hand. After that, we moved to the Windows system payroll package. On the instructions of the Director of Finance, I transferred the salaries to employees' respective bank accounts directly by the "E transfer" method with the Windows payroll package of Accsoft Solutions. This change was very successful.

Then the Accounts package also changed from the Dos system to the Windows package, which is much more convenient for managing Accounts, Stores, and Marketing related work by minimising manual work.

When handling multiple internal financial transactions and backend work, what are the issues, and how do you resolve them?

One of the main issues faced is the non-provision of supporting documents for some payments from related staff. In such incidences, we have to follow up often, which can lead to insufficient time to process the payments. We have to remind the staff to adhere to organisational finance procedures.

Then there are instances that issues arise with the banks and supplier companies. Through discussions with our Director of Finance, we receive guidance to implement systems and procedures to resolve the issues.

Environmental factors such as pandemic restrictions can cause delays affecting internal finance systems and procedures. How do you and your colleagues balance unit cohesion and donor requirements?

During the recent COVID-19 pandemic situation, we had to work from home. We, as a team, managed to do our work accordingly and met the deadlines with the support of online platforms.

Work-life balance is important. Please share some words of advice on how you did it as a working parent.

I think planning is the best method for a better work-life balance. We should set priorities and create a schedule around these priorities. There has to be a designated time allocated to work and personal life that you follow.

FPA works with the community and key population-led organisations in Colombo and Gampaha that employ outreach workers trained to provide a service package that includes prevention services, condom and lubricant distribution, case finding, linking to PrEP clinics and conducting Rapid testing for community members.

Community HIV testing and PrEP clinics are conducted on Sundays and holidays at night to provide easy access to these communities. Delivery of self-test kits, providing assisted self-testing services and linking reactive clients to STD clinics for confirmation, network tracing and supporting the treatment process for new young PLHIV members are some of the services provided by outreach workers.

HIV testing happens in the following settings:

- Government STD clinics (free) - routine (ELISA Test) or rapid testing depending on resources available due to the current situation in the country

- Private Hospitals
- FPA and other service providers

- Community clinics targeted at Key populations

(sex workers, drug users, transgender, etc.).

Outreach workers are trained to do rapid HIV tests or assist in self-testing in the field.

Home delivery services to deliver health products such as HIV self-test kits, condoms and lubricants to the doorstep are also offered through this platform.

Going forward, FPA's clinic staff will also promote this platform to visiting clients.

NEWS FROM The Federation

IPPF celebrates its 70th Anniversary this year as well as its General Assembly.

This year's IPPF General Assembly was held in Bogotá, Colombia in November. The objective of the forum was to bring together IPPF's Member Associations from across the world to agree and approve of IPPF's global strategy for the next 5 years. The takeaways:

1. Stark need to improve funding for youth-led programmes and prioritise youth-budgeting

2. Introduce more learning and global exchange programmes so that young people can learn from one another

3. Recognise the importance of hosting more regional and global youth interaction

4. Make every country's Member Association a safe space for young people to deliberate and act

5. Enable Intergenerational growth so that young people get a seat at decision making tables

IPPF EMBRACES NEW Strategy as it celebrates Its 70th Birthday



IPPF, the world's largest sexual and reproductive health and rights (SRHR) organization, is celebrating its 70th birthday by embracing a new and bold global strategy.

The International Planned Parenthood Federation was founded on 24th November 1952 in an act of international solidarity between eight national family planning organizations. Now it has a network of more than 108 independent Member Associations (MAs) working in over 140 countries worldwide.

IPPF heralded its 70th Birthday with a renewed strategic vision. More than 300 members from IPPF MAs affirmed the new six-year strategy - Come Together - at its General Assembly in the Colombian capital, Bogota, committing to building a future where more people in more places have what they need to enjoy their rights to sexual and reproductive dignity and well-being.

The new strategy sets out an ambitious programme of work over the next five years and provides a compelling focus on revitalizing the Federation. It is accompanied by an Anti-Racism Declaration of Intent, a statement of public accountability to continue working to dismantle racism internally and externally.

To increase its impact and reach, IPPF is committing to bold and catalytic transformation driven by young people. To broaden access to the enjoyment of sexual and reproductive health and rights, IPPF's new strategy sets up four central pillars:

- 1.Centre care on people. IPPF will provide high-quality, person-centred care to more people in more places.
- 2. Move the sexuality agenda. IPPF will push for the societal and legislative change needed to make universal sexual and reproductive rights a reality for more.
- 3.Solidarity for change. IPPF will build bridges to other movements, sectors, and communities wherever sexual and reproductive health and rights can also help advance other human rights causes.
- 4.Nurture our Federation. IPPF will make its core values more explicit and apply their implications across the Federation more comprehensively to unleash stronger collective power for deeper global solidarity that can deliver a greater impact.
